PRIVACY POLICY

Privacy Notice for Kids for Global Peace, Inc Website

This is the Website for Kids for Global Peace. Kids for Global Peace has created this privacy notice to demonstrate our firm commitment to internet privacy. The following discloses our information gathering and dissemination practices for this Website. The type and amount of information received depends on how you use the site.

Kids for Global Peace reserves the right to modify the information contained on this site at any time without notice. This site and all information and materials on it are provided to you "as is" without warranty of any kind.

1 - Normal Website Usage

You can visit most portions of the Kids for Global Peace's Website without telling us who you are and without revealing any personal information. The only information we collect from a normal Website visit is the name of your Internet service provider, the browser and type of machine you are using, the Website that referred you to us, the pages you request and the date and time of those requests.

We use this information to generate statistics and measure site activity to improve the usefulness of the site to our visitors. During a normal Website visit, we do not collect or store personally identifiable information such as name, mailing address, email address, phone number or social security information of the visitor.

We collect the IP addresses of visitors, time of access, browser type, and web pages visited. We collect this information on an aggregate basis only. For example, we track which pages are most popular among visitors as a whole. This information is used for internal review only and not shared with third parties. We do not track information on which pages an individual visitor might look at during a visit to our site. We do not collect any other information without the visitor's knowledge and permission.

2 - Collection of Personally Identifiable Information

There are instances where Kids for Global Peace requests personally identifiable information to provide you with services or correspondence (such as petitions and actions). This information, such as name, mailing address, email address, type of request and possibly additional information, is collected and stored in a manner appropriate to the nature of the data by Kids for Global Peace and is used to fulfill your request. Kids for Global Peace makes every effort to insure the secure collection and transmission of sensitive user information using industry accepted data collection and encryption methodologies such as SSL (Secure Sockets Layer). The information you provide is used by Kids for Global Peace to improve the services we provide our visitors.

Personally identifiable information that you enter as part of the Website's online activism opportunities will not be given to any other organization.

The only circumstance in which Kids for Global Peace may sell, rent, or exchange limited personally identifiable information (such as name and mailing address) with partner organizations is when persons join as dues-paying members online and become part of the Kids for Global Peace regular membership list. Procedures for opting are listed below. Kids for Global Peace does not sell, rent or exchange e-mail addresses to partners. Kids for Global Peace, likewise, does not disclose any financial information to partners.

Some of the activist functions of our site require registration or personal information (like their name and email address). We use this information to track the usage of these features. Users may opt-out of receiving future mailings. Financial information that is collected is used to bill the user for products and services.

Our site uses order forms for users to request information, products and services, or to make donations. We collect visitor's contact information (like their email address) and information on the referring Website, if applicable. Contact information from the order form is used to send orders and information about our company to our users. The user's contact information is also used to get in touch with you when necessary. Users may opt out of receiving future mailings.

The Kids for Global Peace Website will not post personal contact information for volunteers, including their email address, street address and phone numbers, without that individual's consent. Staff and volunteers who submit material for the Website are responsible for securing permission from any volunteer whose personal contact information is to be posted on the Website and for communicating that consent to Website staff. Without such consent, Website staff will withhold posting personal contact information for that individual.

3 - Opting Out

All persons who join or donate to Kids for Global Peace, whether via regular postal mail, over the phone or through the Website, will receive periodic updates from Kids for Global Peace by these same methods (regular mail, phone or e-mail). You may request limited mail updates or request no phone calls by contacting Member Services. Further, we may occasionally exchange or rent the names and postal addresses of our members with other organizations in exchange for access to their member or supporter lists, so that we can invite others to join Kids for Global Peace. If you prefer to opt out having your name, address, email or phone number exchanged in this manner, please contact Member Services.
